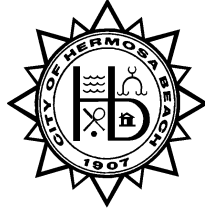

**PROCEDURES FOR APPEALS TO THE BOARD OF APPEALS**

1. Appeals shall be made in writing, upon appropriate forms provided by the Community Development Department.
2. Appeals shall be accompanied by a filing fee as set forth in the Building Fee Schedule.
3. If the Board determines that evidence or further investigation is necessary to decide any appeal, the Board may refer the matter to the Department for further investigation and report.
4. The appellant shall cause to be made at appellant's own expense, any test required by the Board to substantiate a claim.
5. The Department shall prepare an agenda and post same 72 hours prior to the appeal hearing.
6. A copy of the Board's determination shall be mailed to the appellant.
