SIGNATURE VERIFICATION STATEMENT INSTRUCTIONS

It has been determined that the signature you provided on your Vote By Mail or provisional ballot identification envelope does not compare with the signature(s) on file in your voter record. In order to ensure that your Vote By Mail or provisional ballot will be counted, a Signature Verification Statement **must** be completed and returned as soon as possible.

If you do not follow these instructions, it may cause your ballot not to be counted.
Read these instructions carefully before completing and signing the statement.

Choose one of the following ways to return your completed Signature Verification Statement:

- **Return to an Official Ballot Drop Box** throughout the county starting October 10 through November 8, 2022. The statement must be dropped off by 8:00 p.m. on November 8, 2022. Beginning November 9, 2022, through 5:00 p.m. on December 5, 2022, you may drop the statement in a Ballot Drop Box located at the Government Center Hall of Administration or Government Center Hall of Justice. - **Place the statement into the postage-paid return envelope or use your own mailing envelope** with sufficient postage and addressed to: Elections Division, OFFICIAL BALLOT INFORMATION, 800 South Victoria Avenue, Ventura, CA 93009-1200. Completed statements must be received no later than 5:00 p.m. on December 5, 2022. **Postmarks will not count.**
- **Email to VenturaVoterRegistration@ventura.org.** The statement must be received no later than 5:00 p.m. on December 5, 2022.
- **Fax to (805) 648-9200.** The statement must be received no later than 5:00 p.m. on December 5, 2022.
- **Drop off at a Vote Center** throughout the county starting October 29 through November 8, 2022. The statement must be dropped off by 8:00 p.m. on November 8, 2022. For more information on the Vote Center Locations go to: www.venturavote.org

Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

I declare under penalty of perjury that I received and returned a Vote By Mail or provisional ballot. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the Vote By Mail or provisional ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.
