201. Mission Bay Improvement Fund Fiscal Year (FY) 12

A memo prepared by Jim Winter, Project Officer, was dispersed. For FY 12 the Mission Bay Park Improvement Fund is to receive \$2,449,127.00. The first priority project identified in Charter 55.2 involves the restoration of navigational waters within Mission Bay Park by dredging those areas currently identified by the existing Capital Improvement Project (CIP) # B-10163. The Park and Recreation Department recommends the Oversight Committee approve all proceeds from the FY 12 lease revenue be allocated to the existing Mission Bay Dredging CIP project.
