General: The City of Bishop requests bids for the purchase of equipment and materials to upgrade the electrical service at the Bishop sewer plant, 980 Poleta Road, from 200 to 400 amps. The purchase includes the installation of the equipment and materials in conformance with the California Building Code.

Bids shall be delivered to Bishop Public Works at City Hall at 377 West Line Street, Bishop, California 93514, or publicworks@cityofbishop.com. Bids shall be accepted until 3 pm on the close date of this request and shall be clearly identified "Sewer Plant Electrical Purchase Bid". For more information call 760-873-8458.

Purchasing Preferences: City of Bishop contracting preferences apply to this purchase. The city provides a preference to small and local businesses in accordance with Section 3.26 of the Municipal Code.

- One 400 amp 120/240 3 phase 4 wire main speedy board with underground feed with 225 amp 3 pole sub feed breaker to feed existing transfer panel and provision for future breaker spaces
- Eighty feet 4 inch schedule 40 polyvinyl chloride conduit

- Six 4 inch by 48 inch polyvinyl chloride conduit sweeps
- Six 4 inch polyvinyl chloride conduit couplings
- Twenty feet 2 inch polyvinyl chloride conduit
- One 2 inch polyvinyl chloride 90 degree elbow
- Two 2 inch rigid 90 degree elbows
- Two 2 inch polyvinyl chloride female adapters
- Two 2 inch electrical metallic tube watertight connectors
