Referendum on Redistricting Timeline		
+30 days 1/13/2022	A referendum/challenge to maps must be filed within 30 days of adoption to be effective.	
+30 days 2/12/2022	Once filed, Elections office has 30 days to verify signatures.	
E-88 3/11/2022	Once a referendum is deemed sufficient, and is presented to the Board, the Board will have 10 days to issue order for election to take place not less than 88 days from the day of the order.
