FINANCIAL HARDSHIP

The cost of providing full compliance with the accessibility provisions of the 2016 CBC Chapter 11B requirements will impact the project in the following way(s):

In lieu of making the entire facility comply with current accessibility requirements, CBC 11B-202.4, Exception 8 states that for projects with an adjusted construction cost **exceeding** the current valuation threshold noted above, and where the enforcing agency determines full compliance would create an unreasonable hardship, compliance shall be provided by equivalent facilitation or to the greatest extent possible without creating an unreasonable hardship, but in no case shall the cost of compliance be less than 20% of the adjusted construction cost of alterations, structural repairs or additions.
