In accordance with the California Health and Safety Code 25001, all vehicles that transport cleanings and pumpings from septic tanks, chemical toilets, cesspools, seepage pits etc. in Alameda County, are required to have their vehicle inspected and renew permits annually. A copy of a receipt from the sanitary district where the effluent is discharged is required to be returned with the application. Vehicles that have not been inspected before by this agency have to make an appointment for an initial inspection. (510) 567-6756

#### Procedure for Application

1. Contact this office at tel. (510) 567-6756, M-F 8:30-5:00, if there are any any changes to the operation with regards to where the effluent collected is being disposed. An inspection of the truck maybe required at this time.
2. Fill out and mail or fax (510) 337-9234) the "application for registration" Mail to the Department of Environmental Health  
Office of Solid/Medical Waste Management, 1131 Harbor Bay  
Parkway, Room 234, Alameda, CA. 94502.

Exception: If you are currently a registered hazardous waste hauler with the Department of Health Services, please provide us with a copy of your permit and your fee will be waived if your application is approved.
