## Attachment A Form 806 – Agency Report of Public Official Appointments

- 1. Length of Term: Trustees serve on their designated committees for a one-year term until the Board/Chair appoints/elects new committees, which generally takes place each January, or until the Trustee's term on the Board ends or a new Trustee is appointed to his/her seat, whichever comes first.
- 2. In addition to the stipend received for committee service as stated in the Form 806, Board of Retirement (BOR) and Board of Investments (BOI) appointed or retired trustees receive a \$100 stipend for each Board meeting they attend, up to a total of \$500 per month for all Board and committee meetings.
- 3. Appointed and retired Trustees serving on the Board of Retirement, currently including Alan Bernstein, JP Harris, Wayne Moore, Patrick Jones, Antonio Sanchez, Les Robbins, and Gina Zapanta, also receive payment of \$15.68 per hour for up to 8 hours per day (\$16.88 effective April 1, 2022), not to exceed \$125 per day (\$135 effective April 1, 2022), and 32 hours per month, in time spent on review and analysis of disability retirement cases. Such payment is subject to a cost-of-living increase in even numbered years.
- 4. Appointed and retired Trustees serving on the Board of Investments currently include Patrick Jones, Onyx Jones, Elizabeth Greenwood, Joseph Kelly, and Gina Sanchez.
- 5. The Board and committee service of active general and safety member elected Trustees and the ex-officio member is part of their County employment and no additional compensation is paid to them for meetings or review and analysis of disability retirement cases or other aspects of service as a trustee. The active general and safety member elected trustees on the Board of Retirement are Vivian Gray, Shawn Kehoe, William Pryor, and Herman Santos. The active general and safety member elected trustees on the Board of Investments are David Green, Shawn Kehoe, and Herman Santos. Los Angeles County Treasurer and Tax Collector Keith Knox is the ex-officio member on both Boards.
