Title: Escheatment of Unclaimed Funds to the City of Covina in Accordance with the Escheat of

Unclaimed Property Policy

Recommendation: Authorize staff to pursue the escheatment of unclaimed funds to the City in the amount of

\$23,448.06 and approve the transfer of any available funds remaining unclaimed to be recognized as revenue in the General Fund in accordance with the Escheat of Unclaimed

Property Policy.

EXECUTIVE SUMMARY:

On December 18, 2018, an updated Escheat of Unclaimed Property policy was adopted and approved by the City Council establishing a uniform and cost-effective method for the treatment of abandoned or unclaimed money in the City's procession consistent with California Government Code Sections 50050 through 50056. Accordingly, staff has reviewed the unclaimed funds presented in Attachments A and B, and recommends escheating the funds to the City in accordance with the policy.

BACKGROUND:

Each year the City of Covina routinely issues checks for vendor payments and various types of refunds. The City accumulates outstanding checks that remain unclaimed, although attempts are made to contact payees in order to reissue the checks. Additionally, monies have accumulated in the Police Department Evidence fund that result from various Police Department activities and have remained unclaimed and can become the City's property.

DISCUSSION:

Section 50050 of the California Government Code states that uncashed checks with an individual amount of \$15 or more, and more than (3) years old may become property of the City of Covina following publication in a newspaper of general circulation published in the local agency by the Treasurer once a week for two successive weeks. As of December 31, 2020, the City held a total amount of \$11,989.12 as detailed in Attachment A.

The Police Evidence Reserve fund has \$10,758.77 in unclaimed monies pertaining to Police Evidence and Found Property/Safekeeping cases. These funds accumulate as a result of various Police Department operational activities including processing of evidence and found property. These monies also meet the criteria under Section 50050, and are illustrated in Attachment A and can be escheated.

Notice will be published once a week for two consecutive weeks beginning on January 21, 2021, and January 28, 2021, in the San Gabriel Valley Examiner. All valid claims received by the filing deadline of February 26, 2021, will be processed within sixty days. Amounts subject to California Government Code Section 50050 totaling \$22,747.89 (less any valid claims), will be recognized as revenue in the General Fund of the City on March 15, 2021, not less than forty-five (45) days; nor more than sixty (60) days after the first publication of the notice.

Furthermore, Section 50055 of the California Government Code states that uncashed checks that are more the (1) year old and less than \$15, may be transferred by the City's legislative body to the General Fund without public notice in a newspaper. The City's general ledger shows unclaimed refunds with an individual amount of less than \$15 that are twelve months or older totaling \$700.17. Upon approval of the City Council, these funds may be transferred to the General Fund and recognized as revenues.

Instructions for claiming unclaimed property have been posted on the Covina City Hall bulletin board located at 125 E. College St, Covina, CA 91723. The Claim for Unclaimed Property form has also been placed in the Covina City Clerk's office and can be completed with proper supporting documentation and can be mailed to or dropped off at the Administrative Services Department – Finance Division of Covina City Hall. These documents are attached hereto as Attachment C & D respectively.

FISCAL IMPACT:

Upon completion of the noticing and escheatment protocols, any remaining unclaimed funds, up to the amount of \$23,448.06, will be recognized in the General Fund – Other Revenue Account 1010-0000-48990.

INSTRUCTIONS FOR CLAIMING UNCLAIMED PROPERTY

To file a claim for unclaimed property:

- To make a claim for unclaimed money, the claimant must complete and submit a Claim for Unclaimed Property form. Please include all required documentation. NOTE: A separate claim form is not required for each item of property owned by the same owner. Just add additional pages as needed to provide the pertinent information for each item of property claimed.
- 2. The form may be typed or filled out by hand in black or blue ink.
- 3. For all claims, the claimant must show proof of identity and proof of ownership of the property. Proof of identity may be provided by a valid governmental photo identification (e.g., driver's license, passport, or a government employer identification badge). Proof of ownership will vary depending on the nature of the property claimed, but may include proof of residence or ownership at a particular address or proof of a relationship (vendor, employee, contractor, etc.) with the City at a specified time.
- 4. If the claimant is claiming the money on behalf of a business entity, the claimant must provide proof that he or she has legal authority to make such request. Proof of authority can be, for example, but is not limited to, a signed letter from the owner or CEO of the company on company letterhead.
- 5. If the money is being requested to be paid to someone other than the original owner or payee (e.g., to a person instead of to the business entity), the City requires a written, signed statement made under penalty of perjury and other pertinent legal documents which shall justify the change in payee.
- 6. All pertinent information called for on the form must be filled in or otherwise provided.

 The claim form must be signed by the claimant, and the signature must be notarized if the claim is for \$100 or more.
- 7. For claims submitted by an agent on behalf of the claimant under power of attorney, the power of attorney form must have the notarized signature of the claimant, and the claim form must also have a notarized signature of the claimant.
