This is a rectangular plan front gable commercial building with a faux front. The building is of frame construction with a moderately pitched gable roof with only a slight eave overhang. The gable end is hidden by a false front stepped pediment intended to give the building a more imposing street presence. A recessed central entry is flanked by storefront windows. The entry is elaborated with pilasters at the edge of windows. An elaborated dentil cornice extends across the front elevation just above the entry and windows. The sides and rear of the building are clad with clapboard siding which is probably original. The front elevation has been covered with stucco...

The building has the massing, form and basic features of a typical commercial/retail establishment from late 19th or early 20th century Benicia. The integrity of the building's location, setting and association remains intact. However, the refinishing of the front elevation has had a substantial impact on the integrity of the building's materials and workmanship. Because the alterations are to the front façade, the most important elevation in a building of this type, the store front no longer retains sufficient integrity for listing as a contributor in the Downtown Historic District. Since the original elements of the building appear to remain under the alterations, the building might qualify for listing if it was rehabilitated.


