IT IS FURTHER RECOGNIZED that pursuant to sections 10503(c) and (d) of the Commission's regulations and Standard Conditions _______ to this permit, this agreement and deed restriction is a covenant running with the land for as long as the terms and conditions of the permit remain in effect or for so long as any use or construction authorized by this permit exists, whichever is longer, and shall bind the permittee(s), and the permittee's(s') heirs, successors, and assigns.
