Bulky Items, White Goods & E-Waste Recycling

Items that cannot properly fit in your bin, such as a chair or desk, are considered bulky items and require a special pick up. White goods (i.e. refrigerators, freezers) and electronic waste cannot be disposed of in your bin. Electronic waste (e-waste) is anything with a circuit board or battery, such as computers, telephones
