



# City of Santa Clarita Community Court and Teen Court Diversion Program

## Consent Agreement

In the matter of \_\_\_\_\_, a minor.

I, \_\_\_\_\_, a minor under or about to come under juvenile court jurisdiction pursuant to Welfare and Institutions Code Section 601 or Welfare and Institutions Code Section 602, and having agreed to participate in the Community Court/Teen Court Diversion Program, hereby acknowledge that I understand the following:

1. The format and purpose of the Community Court/Teen Court as set forth in the Program Description.
2. My consent to participate in Community Court/Teen Court is knowing and voluntary. By agreeing to participate in this diversion program, I am knowingly waiving my right to a speedy trial in the traditional juvenile court system, waiving my right to a jury trial, and waiving my right to an attorney.
3. I understand the Community Court/Teen Court hearing is open to the public, and by signing this form, I knowingly waive my rights to confidentiality for Community Court/Teen Court purposes only.
4. The disposition of the Judge of the Community Court/Teen Court may include, but is not limited to, a combination of the following: community service, educational workshops, essay, letter of apology, restitution, and/or counseling. By signing this form, I and my parent(s) agree to accept and complete the Community Court/Teen Court disposition.
5. Any and all activities ordered by the Community Court/Teen Court for me will be under the authority, supervision, and control of the Los Angeles County Sheriff's Department.
6. Only after my disposition has been successfully completed will my case be closed with no further criminal action taken. I also understand that if I fail to complete the disposition as set forth in the timeframe given, or I get arrested before I have completed the disposition, I will be automatically expelled from the Program and my case will be returned to the traditional justice system.
7. I authorize the City of Santa Clarita Community Court/Teen Court Coordinator, or designee, to release information to the staff of the Santa Clarita Community Court/Teen Court Diversion Program. I understand that the option of Community Court/Teen Court may be withdrawn if a review of law enforcement records reveals that I am a member of, or associated with, a youth gang, or have been involved in criminal activity unknown to the Coordinator at this time, or if I am involved in new criminal activity prior to the successful completion of the program.
8. ***It is further agreed and understood*** that as a condition of participation in the Santa Clarita Community Court/Teen Court Diversion Program, I and my parent(s) or legal guardian(s) promise to hold harmless the City of Santa Clarita, its officers, employees, agents, the Santa Clarita Community Court/Teen Court, staff, instructors, the Sheriff's Department, and any community service agency or individuals from any and all actions, causes of action, or any claims whatsoever, which may arise out of my participation in any activity of the Santa Clarita Community Court/Teen Court Diversion Program.
9. Court fees are non-refundable.
