***P3a. Description:**

A residence of similar form appears on the 1913 and 1913-42 Sanborn Maps at the same location. According to the 1986 Historic Survey form the present house incorporates a much earlier residence and was remodeled to its current appearance in 1933. It was evaluated as significant because of the occupation of the house by the Gonzalves family who represented the life ways of the Portuguese community in Benicia (see Survey form). Current California Register standards require that properties important for their association with an individual must be associated with an individual that made a direct and specific historic contribution of importance to local or regional history. Under these standards the house would not be significant for its association with a "typical" family representative of an ethnic community. The historic district context developed in the Downtown Historic District Conservation Plan did not address the history or significance of resources related to the Portuguese, or any other, immigrant group. At such time as an expanded context statement for the Downtown District is prepared that addresses the question of distinctive ethnic community resources this residence should be re-evaluated. At the present time it does meet criterion B, nor does it qualify as a representative of its period and style.
