A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF YUCCA CALIFORNIA, CERTIFYING BALLOTING RESULTS AND CONFIRMING THE ASSESSMENTS APPROVED BY THE VOTING LANDOWNERS FOR STREET AND DRAINAGE MAINTENANCE DISTRICT NO. 1, ANNEXATION NO. 4, ZONE 5 FOR PM 17455.

 - c. Total Ballots Processed in Favor of the Proposed Assessment: 1
 - d. Assessment Amount of Ballots in Favor of Proposed Assessment: \$13,890.00
 - e. Total Ballots Processed in Opposition to the Proposed Assessment: 0
 - f. Assessment Amount of Ballots in Opposition to Proposed Assessment: 0
