MANUFACTURED HOME – APPLICATION CHECKLIST

ALL APPLICATIONS REQUIRE THE FOLLOWING ITEMS: (In addition to the Application for a Permit)

- □ 4 floor plans with room dimensions and uses labeled (i.e: bedroom, living room, bathroom, etc.).
- 5 plot plans (2 signed by fire district, if other than CDF; **Not required on retrofit foundations**)
- One approved Installation Manual with blocking tagged & highlighted and (2) sets of marriage line plan specifying the layout to be used for the *specific snow load*. If the manual is not available see Building Division "Manufactured Homes - No Manual" Not required on retrofit foundations.
- □ Copies of original septic and well permits, if replacing an existing manufactured home. A waiver from the Environmental Health Division will be required. **Not required on retrofit foundations.**
- □ Grading Plans (see information packet on grading). Must include wet weather plans if grading between October 15th and May 1st. <u>Not required on retrofit foundations.</u>

ADDITIONAL INFORMATION FOR ANCHORING / FOUNDATION SYSTEMS - (CHOOSE ONE)

- A. *TIE DOWNS* ALSO REQUIRE THE FOLLOWING ITEM:
 - □ Title Search on used Manufactured Homes (Request from escrow officer or *HCD). Not required on new units.
 - 2 sets of engineered tie down system plans approved by the State of California or a licensed California engineer. Must state the current Building Code Cycle.
- B. CHATTEL FOUNDATIONS ALSO REQUIRE THE FOLLOWING TWO ITEMS:
 - □ Title Search on used Manufactured Homes (Request from escrow officer or *HCD). Not required on new units.
 - 2 sets of foundation plans for the specified snow load, approved by the State of California or a licensed
 California engineer. Must state the current Building Code Cycle.

C. PERMANENT FOUNDATIONS ALSO REQUIRE THE FOLLOWING ITEMS:

- □ Title Search on used Manufactured Homes (Request from escrow officer or *HCD). Not required on new units.
- □ 2 sets of foundation plans for the specified snow load, approved by the State of California or a licensed California engineer. Must state the current Building Code Cycle.
- □ License / Decal from Manufactured Home. If missing, original *HCD "STATEMENT OF FACT" form, signed by Manufactured Home owner(s). Not required on new units.
- □ Owner to provide completed 433(B) at application. Enforcement agency to complete the 433A form at final for recording.
- □ Clear, legible copy of most recent recorded deed with legal description of the property. Faxed and/or *unofficial copies* will *not* be accepted.
- Original Certificate of Title. If the unit is to be paid off, then a letter from the Escrow Officer. If the original Certificate of Title is lost, an *HCD "APPLICATION FOR DUPLICATE CERTIFICATE OF TITLE" to be submitted with original signature of manufactured home owner(s). Not required on new units.
- □ Original registration. If lost, then an *HCD "APPLICATION FOR DUPLICATE REGISTRATION" to be submitted with the original signature of unit's legal owner(s). **Not required on new units.**
- □ Letter from lien holder acknowledging the home will be attached to the real property. If no lien holder, owner to provide a letter stating the home and land are clear of liens.
