I am aware that service on the San Bernardino County Civil Grand Jury is for a twelve-month period beginning July 1 through June 30 of the following year and that such service may require my attendance three days, and possibly up to a five days, per week. Reasonable absences (up to 12 days) are permitted.

I am also aware that I may be requested to participate in an orientation program for up to two weeks in the month of July. It must be understood there is not any provision under the law for compensation for the orientation program.

I am further aware that as compensation for my duties as a Grand Juror, I will be paid \$60.00 for each day of service and roundtrip car mileage at the current rate. Parking is provided.

I hereby state that I am capable of carrying out my duties as a member of the Civil Grand Jury and that I have no plans for extended vacation, travel, or business (more than 12 business days) which would prevent me from serving the required amount of time. I will not change residence outside the County of San Bernardino during my term as a Grand Juror.
