

This house was originally a two-story cottage with a Gothic Revival form, but lacking in any Gothic Revival detailing. It is impossible without historic photographic documentation to know if it was constructed without embellishment, or if the typical detailing of this type of house was removed or deteriorated over time. Originally rectangular in form the house has been substantially altered with a one-story addition to the east and a large wrapped porch addition that extends across the front and east facades. The foundation also has been raised foundation. The roof is cross gabled with a steeply pitched projecting front gable centered over the original entry. Gables and eaves are overhung. While fenestration remains in the original configuration, all of the glazing has been replaced. The current porch incorporates the original steep gable entry cover, but is otherwise hipped. The new porch roof is supported on square posts and is enclosed with an open rail.

This house was originally a rectangular Gothic Cottage with a cross gable roof and a central covered entry. It had no visible foundation. In the 1990s the house was substantially altered. While retaining the central core of the earlier house, it was elevated on a new foundation, the fenestration was changed and a large wrapped porch was added. These changes undermine the integrity of the historic house in terms of design, materials, workmanship, feeling and association. The house is no longer a good example of its architectural style and does not convey a sense of the period in which it was built. It is currently listed as a contributor to the Benicia Downtown Historic District. Because of the numerous and inappropriate alterations it should be removed from contributing status.


