This residence is a rectangular plan Queen Anne Cottage with an elaborate porch structure. The building has a cross gable and hip roof. The front gable is finished with a fascia and a plain cornice. The gable end exhibits fish-scale shingles and a half-moon attic vent. Canted bays and a centered porch project from the front elevation and share a single flat roof with an elaborate dentil trimmed cornice and decorative frieze. A central porch extends between the symmetrically arranged bays. The canted porch entry is supported on turned posts with arched trim. An open and cut-out rail encloses the porch which is accessed via a wooden stair with turned balustrade and newel posts. The porch is unusual in its design and gives the house a very distinctive appearance. Fenestration consists of one-over-one narrow windows. Cladding is clapboard.


