#### INSURANCE/INDEMNIFICATION REQUIREMENTS

## 1. Insurance Requirements

Applicant/Organization is required to provide insurance naming the City of Camarillo and its officers, employees, consultants and agents as additional insureds for general liability and automobile coverage with policy limits of at least \$1,000,000 per occurrence which insurance shall be primary and non-contributory. Applicant must submit proof of insurance to the City in the form of a Certificate of Insurance and an Endorsement prior to the issuance of this permit by the City.

### 2. Indemnity Requirement

Applicant/Organization agrees to release, hold harmless, indemnify, and defend, the City of Camarillo ("City") from and against, any and all liabilities, claims, actions, causes of action, proceedings, suits, damages, judgments, liens, levies, costs and expenses of whatever nature, including reasonable attorneys' fees and disbursements (collectively, "Claims"), which City may suffer or incur or to which City may become subject to by reason of or arising out of any injury to or death of any person, damage to property, loss of use of property, economic loss or otherwise occurring as a result of or allegedly caused by the negligent or willfully wrongful acts or omissions of User in its use of the premises.
