Installation and Inspection of Field-Applied Grease Duct Enclosures

Inspections of approved field-applied grease duct enclosure products shall be performed by CSJ pre-approved 3rd party Special Inspectors certified and endorsed by the product manufacturer to provide inspection services, or the CSJ Mechanical Inspectors, in accordance with the approved plans, specifications, product listing, manufacturer's installation instructions and applicable sections of the California Mechanical and Building Codes. The City of San Jose reserves the right to assume special inspection responsibilities or defer inspection services to a certified and approved 3rd party Special Inspector at any time when deemed appropriate.

BEFORE A PERMIT IS ISSUED: The building owner, building owner's agent or registered design professional shall submit appropriate plans to the City of San Jose Building Department for review of the proposed mechanical systems. Mechanical plans shall include detailed information for all Type I hoods, ducts, fans, support systems, cleanouts, and equipment prior to approval. Roof plan, floor plan and installation details for mechanical systems and field-applied grease duct enclosure shall be included. Two copies of this completed form wet signed by all parties shall be submitted for review and approval prior to permit issuance.

- 1. Mechanical contractor shall:
 - a. Install all mechanical systems in compliance with the approved Mechanical plans, ordinances and local Codes.
 - b. Request inspection and obtain approval of mechanical grease exhaust systems prior to concealing or product installation.
- 2. Field-applied grease duct enclosure installing contractor shall:
 - a. Present names, qualifications and/or certifications to the Building Official for each installer upon request.
 - b. Review the approved plans and this document for installation and inspection requirements prior to product installation.
 - c. Confirm authorization by CSJ Mechanical Inspector to install product prior to any product installation.
 - d. Install product in accordance with the terms of the listing and the manufacturer's installation instructions.
 - e. Confirm that where CSJ Inspector is used, only first layer of product will be installed before product inspection is requested.
 - f. Confirm that where 3rd party Special Inspection is provided, product installation will only proceed in the presence of the Special Inspector named on this document.
- 3. Field-applied grease duct enclosure 3rd party Special Inspector shall:
 - a. Be certified by the product manufacturer and approved by the City of San Jose to inspect the specific product installed.
 - b. Use only the approved Mechanical plans, City of San Jose field inspector's notes, manufacturer's installation instructions and terms of listing to ensure proper product installation.
 - c. Provide continuous inspection services and immediately notify the Building Official of any concerns, problems or issues.
 - d. Submit complete inspection reports to the Building Official during and/or upon completion of product installation, as required.
 - e. Remain in good standing and repute with the City of San Jose Building Department.
- 4. City of San Jose Mechanical Inspectors shall:
 - a. Perform inspections on grease duct systems and approve installations prior to allowing product installation.
 - b. Perform two-staged inspections. First layer initial inspection followed up by second layer final inspection.
 - c. Perform final inspection of and approve field-applied grease duct enclosure installation prior to ceiling closure in all cases.
 - 1. Have the authority to request a certified 3rd party Special Inspector at any time during the process, when deemed appropriate.
