

Other Locational Data (APN #): 89-044-21 **Description:** *P3a. This Craftsman Bungalow, like its neighbor at 175 West H Street, is built low to the ground with a strong feeling of horizontality. The building has a double gable roof of moderate pitch with exposed rafters. A narrow fascia trims the gable which has a louvered attic vent. The house is L-shape in plan with a projecting front gable wing facing the street on the west side of the building. A flat roofed porch occupies the east side. The roof is supported with a row of exposed bird's beak purlins and double full length battered posts. Fenestration is composed of a double hung front window with double hung sidelights, all one-over-one. Double hung windows occur elsewhere as well. Cladding is clapboard. *P3b. Although not as elaborate as its neighbor, the house is a good example of the Bungalow Style. There are several bungalows on this block of H Street which together provide a good sample of the bungalow residential architecture that was introduced in Benicia in the teens and 1920s. This is one of two infill houses that were built on the site of the former garden of the J.W. Jones house at 187 H Street. The integrity of the fenestration has been marred by the replacement of the original windows in the front with vinyl sash. With the exception of the window, the house retains its major character defining features and is clearly recognizable as an example of its type. It contributes to the Downtown Historic District and should continue in this status.
