October is Domestic Violence Awareness
Month and Breast Cancer Awareness Month.
The DA's CARE Center is hosting a resource
fair on October 19 to focus on these two very
important issues. (See details below.) We've
partnered with the San Diego Domestic
Violence Council, Susan G. Komen, Office of
Binational Border Health, Binational Health
Week, Every Woman Counts, and Vamos a
Charlar to bring an array of services to this
month's resource fair. During the event,
there will be three panel discussions with
domestic violence survivors and breast
cancer survivors sharing their stories.

Advocates and experts in the field will also discuss how to identify domestic violence and understanding one's legal rights. There will also be free breast screenings and mammograms. The DA's Victim Assistance Program, the Family Justice Center and other domestic violence-related service organizations will be on site to provide information and assistance. We are so grateful that our partnerships in the community allow us to be able to provide all these services and I hope you'll have time to stop by on October 19.

The Victim Resource Navigation Program has expanded to include PATH (People Assisting the Homeless) as a San Diego location where navigators assist homeless victims of crime. The program has also expanded their support group initiative to include a men's peer support group at the Alpha Project Bridge Shelter. The male residents have been participating in the group regularly and the reception has been overwhelmingly positive. The navigators have started a women's peer support group at PATH as well. These groups are providing a safe space to share their experiences and form connections with others.
