Animal Control Friendly Reminder

This is a friendly reminder officers from the Los Angeles County Department of Animal Care and Control (DACC) began conducting field licensing enforcement in the City of Cudahy on Wednesday, April 29, 2015. This door to door canvasing will continue for the next few months until every household has been visited by animal control officers.

Field enforcement efforts are designed to ensure that residents' dogs and cars are in compliance with licensing requirements. California State law requires that all dogs over the age of four months be vaccinated against rabies and be licensed. Securing a dog or cat license is essential to assisting animal control agencies if a pet becomes lost.

The licensing fees for City residents are as follows:

- Unaltered dog: \$60
- Altered dog: \$20
- Altered dog belonging to a senior citizen (60 years of age or older): \$7.50
- Unaltered cat: \$10
- Altered cat: \$5
- Penalty fee: Equal to the license fee

Pet owners are advised to be in compliance with the City's licensing ordinance. Residents who are not in compliance will be subject to license fees and delinquency charges, including a \$40 field enforcement fee, to offset the cost of the Department's field services. In order to avoid penalties, be sure to license your dog. You can secure a new dog license by printing the application online at <u>http://animalcare.lacounty.gov</u> or visiting your local County animal care center. If your license is not delinquent, you can also renew it online.

Forklift Training Update


On Wednesday, April 28, 2015, our Maintenance staff participated in forklift safety training along with the staff of other cities at Lugo Park. The training provided participants with an understanding of forklift mechanics, equipment inspection, material handling, load capacities, safety and operating procedures. Each trainee took a written test; had to demonstrate proficiency; and took a driving evaluation.

Cudahy Clean-Up Day - Recap

On April 25, 2015, the City partnered with Republic Services, LAUSD Board Member Kayser's Office and Ellen Ochoa Learning Center to put together our 2nd Quarter Clean-Up Day. Students from Ellen Ochoa Learning Center formed a committee to help organize other students at nearby schools to volunteer with the clean-up efforts.

The Clean-Up Day yielded over 45 middle school student volunteers and 40 resident trash drop offs, resulting in five full 40-yard bins. The City hopes to provide residents the same service in the upcoming quarter.





Emergency Operations Center (EOC) Tabletop Exercise

On May 6, 2015, staff will participate in a "tabletop" training exercise. The training will cover Emergency Management, Emergency Operations, and a live training exercise where staff will have an opportunity to use the City's Emergency Operations Center at Lugo Park.

This tabletop exercise will be provided by the City's Emergency Management Consultant, Roger Mason Ph.D., from Law Enforcement Crisis Management, LLC. (LECMgt).

Pet Vaccination Clinic

On Thursday, April 16, 2015 the City of Cudahy in partnership with the Society for California Veterinary & Vaccine Care (SCVVC) and the Los Angeles County Department of Animal Care and Control, held a pet vaccination clinic. They provided veterinary service and vaccines for both dogs and cats. We had a total of 24 dogs and 4 cats. We hope to host another clinic in the near future, please check this report to stay informed.

Finance Department

Mid-Year Budget Approved

At the Tuesday, April 21, 2015 Regular City Council Meeting the City Council received the mid-year budget review that was presented to them. The City Council also adopted a resolution for the use of fund balance reserves to complete projects the City has undertaken.

The City Council approved an amendment to the Fiscal Year (FY) 2014-15 City Budget for the amount of \$202,320 for the General Fund, \$222,771 for the Community Development Block Grant (CDBG) fund, \$300,000 for the Proposition A fund, \$77,000 for Measure R fund, \$40,000 for the County Park Bond fund and \$20,000 for the Federal Surface Transportation Program (Federal STPL) fund.

By approving the FY 2014-15 Mid-Year Budget adjustments, the FY 2014-15 General Fund appropriations totaled \$8,322,691, complying with the Budget Reserve Policy of \$3,000,000 and the

Special Revenue funds appropriation totaled \$7,427,273. This allows the City Manager to rebuild the Human Resources Department, complete the reroofing of Bedwell Hall, and leverage other grant opportunities.

Until such time as the City identifies recurring revenue streams the City is implementing best practices of mid-year budget adjustments, leveraging resources and realistically estimating a spending plan for the remainder of the fiscal year.

Annual Financial Report of the Proposition A, Proposition C, Measure R Local Return Funds and Transportation and Development Act Article 3 Funds.

The independent audit firm of Simpson and Simpson was contracted by the Los Angeles County Metropolitan Transportation Authority to audit the transportation funds received by the City of Cudahy. The transportation funds are used for the Fixed Route, Dial-A-Ride, recreation excursions, Transit Study, Freeway Study, Traffic Signals, Intersections, Street Repair and Maintenance and Bikeway Improvement. Simpson and Simpson concluded their audit and issued an unqualified opinion on the Fiscal Year 2013-14 transportation funds of the City of Cudahy. An unqualified opinion is also referred to as a "clean" opinion and means that the financial information presented can be relied upon by the readers of the financial statements as being materially fairly stated.

Community Development and Services Department

Clara Park Expansion Project Grand Opening and Dedication

As of May 1, 2015 staff is proud to announce the completion of the Clara Park Expansion Project. Although there are minor landscaping elements remaining, the park is completed, open to the public, and has been accepted by the California State Department of Parks and Recreation.

At the April 21, 2015, City Council meeting, Council voted unanimously to dedicate the park expansion to Senator Ricardo Lara. The dedication is in recognition of his hard work and

commitment towards ensuring the allocation of \$1.7 million to the City of Cudahy and continuing with the project. Tentatively, the dedication ceremony and grand opening is scheduled for June 26, 2015, pending Senator Lara's schedule confirmation.

In the mean time, please help the City care for and protect the new park. Although the park is open to the public, the landscaping and grass area needs time to set into the soil. This means that we need to keep off the grass for the next 60 days while we will intermittently watering the new grass and let it set.

The completion of the park would not have been possible without the support of Senator Lara. Additionally, un-wavering support from City Council, management, and the hard work of the City Attorney's office as well as city staff made this expansion come to life. Thank you to all who worked tirelessly to see this project through.





City Seeks US Soccer Foundation Grant

In an effort to offset a shortfall of \$400,000 for the Lugo Park Soccer Field Renovation Project, the City will submit an application in response to the 2015 US Soccer Foundation call for projects, Safe Places to Play grant with a maximum award of \$200,000. Staff will present a proposed contract with California Consulting not to exceed \$8,000 at the May 5, 2015 City Council meeting for the preparation and submittal of the application, which is due May 29, 2015.

Overnight Parking Pilot Program

As the overnight parking pilot program comes to a close June 30, 2015, staff is preparing to bring the item before City Council at both the June 2nd and June 16th Council meetings for review. During the review, staff and Council will consider modifications to the program which will include fees, required qualifications, and implementation.

Lugo Park Soccer Field and Restroom Rehabilitation Project

The City's project management team at Transtech will make a presentation and recommendation for City Council consideration at the May 5, 2015 City Council meeting. Transtech will propose a final design and cost estimate to include a regulation size soccer field, restroom and concession facility, all weather walking path, and protective netting along the north side of the park.



2015 National American Planning Association Conference

On April 17 - 21, 2015, Michael Allen, the City's Acting Community Development Director attended the annual National American Planning Association Conference held in Seattle, Washington this year. The conference hosted over 6,400 planners representing all 50 States in the US and over 24 countries. The City was recognized during a seminar for the public participation in the development of the City-wide Safe Routes to School Program by the Los Angeles County Department of Public Health.

While there, Michael attended over 15 workshops. The workshops focused on pedestrian planning, complete streets concepts, building public/private partnerships, next generation parking requirements and strategies, and disaster recovery. These workshops provided information that will better prepare the City when designing and developing master plans for pedestrians and bicycles, traffic, parks, and streets.







Bedwell Hall Roof Replacement Project (CDBG)

The City of Cudahy is pleased to announce that the Bedwell Hall Roof Replacement Project was completed in April 2015. This project consists of providing all labor, equipment, and materials to replace the existing modified bitumen roof system over the Bedwell Hall building. Additional work, not part of the original scope of work, inside the building has been requested of the contractor. This additional work consists of ceiling repairs at the interior of the building due to water damage.

2016 General Plan Update

In response the the City's request for proposals to prepare the 2016 General Plan Update, three proposals were received on April 24, 2015. Currently a committee of staff are reviewing the proposals and will bring a recommendation for award to City Council at the May 19 City Council meeting.

Renewal of Project JADE and City Prosecutors Contracts

Contracts for Project JADE and the City Prosecutors funded by the Community Development Block Grant (CDBG) have expired and may be renewed. Both contracts will be presented to Council on the at the May 19, 2015 City Council meeting. Project JADE provides parenting classes on a weekly basis at Elizabeth Learning Center to assist parents coping with at-risk youth. The City Prosecutors office handles all civil cases that result from any open unresolved code enforcement cases. Both contracts will be proposed to be extended for a one year term.

Wood Craft Rangers Health Fair

At the May 5, 2015 City Council meeting, Council will consider co-sponsoring a health fair with the Wood Craft Rangers to be held on May 16, 2015 at Lugo Park. If approved, the fair will consist of Soccer, Flag Football, and Parachute drills. They will also have Face painting, Cheer, and Zumba performance. A number of vendors including T-mobile, Planet Fitness, and Jamba Juice will be giving out information and handouts. The Fair will be open to the public and free of charge.

Resurfacing of the Basketball Gym Floor

At the May 19, 2015 City Council meeting, Council will consider a contract award for the re-painting and re-surfacing of the basketball gym floor at Clara Park. Staff is proposing to resurface, repair, and repaint game lines and the City seal. Refinishing the floor will extend the life of the floor for another 10 to 15 years.

Food Distribution

On Thursday, April 23, 2015, the City of Cudahy held its monthly Food Distribution at Clara Street Park. A total of 183 families received goods such as apples, beans, rice, and bread. 23 volunteers were present to assist in the distribution of goods. The upcoming Food Distribution is scheduled to take place on Thursday, May 28, 2015 at 8:30 a.m. Please be sure to have valid proof of residency on hand to avoid being turned away at the door. Fist-time participants are encouraged to make note of the information provided below.

ENGINEERING

City of Cudahy Engineering and Traffic Survey

The City of Cudahy has selected a consultant to prepare an Engineering and Traffic Survey for various streets within the City of Cudahy. The report will be prepared based on a detailed field investigation, survey of travel speeds and accident history of various roadway segments in the City.

The scope of work of this Traffic Study is to prepare Engineering and Traffic Surveys at all major streets within the City in order to establish updated speed limits that can be enforced using radar. Applicable sections of the California Vehicle code (CVC) and Caltrans Manual of Uniform Traffic Control Devices (CA-MUTCD) and Traffic Manual will be followed to prepare this study. The Engineering and Traffic Survey is expected to be completed by August 2015.

City of Cudahy Americans with Disabilities (ADA) Transition Plan

The City of Cudahy will be preparing an ADA Transition Plan to comply with the requirements set by the Americans with Disabilities Act. The plan will detail and schedule how the City will make its streets and roads accessible to disabled individuals. For this purpose the City Staff has selected a consultant to prepare the City of Cudahy ADA Transition Plan.

On July 26, 1990, the Americans with Disabilities Act was enacted, which provides comprehensive civil rights protections to persons with disabilities in the areas of employment, state and local government services, and access to public accommodations, transportation, and telecommunications. Subsequent federal regulations promulgated by the Department of Justice require municipalities, such as the City of Cudahy, to prepare a plan detailing how they will make their streets, roads and other facilities accessible to disabled individuals. This is recognized as the

ADA Transition Plan. The main purpose of the ADA Transition Plan is to develop policies and practices for implementing physical pedestrian improvements within the public right of way.

The City of Cudahy ADA Transition Plan is expected to be completed by August 2015.

Cudahy Citywide Street Improvement Project (Prop 1B)

<u>1) Ferndale Ave/Fostoria St/River Rd/ Cecelia St and Crafton Ave Loop 2) Alamo St and 3)</u> Walker Ave

The Cudahy Citywide Street Improvement Project (Prop 1B) has completed the Bid Phase and is going now to City Council on May 5, 2015, for Contract Services Award.

During the beginning of April 2015, the Engineering Department issued a Notice to Contractors to procure construction services for the aforementioned project. On April 20, 2015, the City Clerk's Office conducted the bid opening meeting at the City Council Chambers. A total of three bids were received for this project from which Sequel Contractors, Inc. was the lowest responsive bidder.

The rehabilitation includes pavement resurfacing, repair of damaged sidewalks, repair of damaged curbs and gutters as well as the installation and modification of corner access ramps to meet the requirements of the American with Disabilities Act (ADA). These improvements will take place on the following local streets: Ferndale Ave, Fostoria St, River Rd, Cecelia St, Crafton Ave, Alamo St, and Walker Ave.

Construction phase will follow after construction contract award and It is expected to be completed by the end of June 2015.

Cudahy Citywide Street Repair and Maintenance Project

The Cudahy Citywide Street Repair and Maintenance Project has completed the Bid Phase and

is going now to City Council on May 5, 2015, for Contract Services Award.

Beginning April 2015, the Engineering Department issued a Notice to Contractors to procure construction services for the aforementioned project. On April 20, 2015, the City Clerk's Office conducted the bid opening meeting at the City Council Chambers. A total of five bids were received for this project from which FS Construction was the lowest responsive bidder.

The rehabilitation includes cold milling existing asphalt concrete and asphalt concrete overlay at specific damaged areas (repair of potholes) and crack sealing existing cracks on asphalt concrete. It also entails the removal and replacement of damaged sidewalks, driveways, curb and gutters, and/ or cross gutters; cold mill existing sidewalks to eliminate tripping hazard, installation and

modification of corner access ramps to meet the requirements of the Americans with Disabilities Act (ADA); as well as the completion of other miscellaneous items, including traffic striping and traffic control.

This project is a citywide project that includes repair and maintenance on all arterials, corridors and local streets within the City's jurisdiction as described in the project scope of work.

Construction phase will follow after construction contract award and it is expected that project will be completed by the end of June 2015.

Atlantic Avenue Street Improvement Project (Phase I)

The Atlantic Avenue Street Improvement Project (Phase I) has completed the Bid Phase and is

going now to City Council on May 5, 2015, for Contract Services Award.

Beginning April 2015, the Engineering Department issued a Notice to Contractors to procure construction services for the aforementioned project. On April 20, 2015, the City Clerk's Office conducted the bid opening meeting at the City Council Chambers. A total of three bids were received for this project from which Excel Paving Company was the lowest responsive bidder.

Atlantic Avenue is a principal arterial in the City of Cudahy and is the main arterial that connects the City with the rest of the Gateway Cities (Bell in the North boundary and South Gate in the South boundary). After a detailed field assessment, it has been determined that this arterial is in need of pavement rehabilitation to prevent infrastructure failures and more costly repairs in the future. The

rehabilitation in Phase I consists of cold milling existing asphalt concrete and asphalt concrete overlay at specific damaged areas (repair of "alligatored areas" and potholes) and crack sealing random existing cracks on asphalt concrete. It also entails the completion of other miscellaneous items, including traffic striping and traffic control.

A Phase II of the project will include a surface treatment such as slurry seal and it will be part of the City's Capital Improvement Program (CIP) for future Fiscal Years.

Construction phase will follow after construction contract award and it is expected that project will be completed by the end of June 2015.




