OBSERVATIONS:

From the last inspection- There has been significant progress towards the dismantling/cage conversion project, most if not all stacked cages that were outside the chicken coops have been removed. Overgrown vegetation still has not been removed, and the scrap metal remains to be removed.

At this inspection- There has been some progress towards addressing the excessive vegetation on site. There was noticeable feed that was spilled under a silo, and the fly traps in coop 12 and 11 needed to be replenished. Finally, the cemented area in the entryway of coop 12 had a significant accumulation of feathers and spilled feed.

RECOMMENDATIONS:

Remove all excessive vegetation around the ranch. Keep cement entries and in the external areas of the coops clean and free of any accumulation of feathers. Properly dispose of sheet metal that has been discarded around the ranch. Keep fly traps in all coops were chickens are being kept replenished.
